WEST WENDOVER CITY COUNCIL MINUTES OF THE REGULAR MEETING OF OCTOBER 19, 2010

The West Wendover City Council met for a regular meeting on October 19, 2010. The meeting was held at the West Wendover City Hall, Council Chambers #137. Mayor Andersen presided.

The following proceedings were had.

1. **CALL TO ORDER AND ROLL CALL**
Mayor Andersen called the meeting to order at 7:00 p.m. All those present and excused are noted above.
2. **PLEDGE OF ALLEGIANCE**
Mayor Andersen led those present in the Pledge of Allegiance.
3. **COMMENTS FROM THE GENERAL PUBLIC:**
None offered or received.
4. ***APPROVAL OF THE MINUTES:**
Council Member Rowley II made the motion to forward the minutes of the regular meeting of October 5, 2010 to the next meeting. The motion was seconded by Council Member Blake and passed unanimously.
5. **NEW BUSINESS**
 - *a. **Discussion and Decision to Approve and Award the Successful and Responsive High Bidder Under City of West Wendover Public Land Sale 10-19-2010 per City of West Wendover Resolution # 2010-21 and Authorization for Staff to Prepare and Mayor to Execute All Necessary Agreements, Documents and/or Contracts and Other Matters Appropriately Related Thereto**
Chris Melville explained that no bids had been received. Chris asked that a motion be made to send a Request for Proposals (RFP) to the realtors and would then bring it back on the November 2, 2010 meeting. Council Member Gorum made the motion to approve the City Manager and staff to prepare the RFP for realtors. The motion was seconded by Council Member Briggs and passed unanimously.
 - *b. **Discussion and Decision Regarding Sponsoring Trick or Treat Street and Other Matters Appropriately Related Thereto**
Councilwoman Carter explained that this was the annual activity. The donation last year was \$590.00. Council Member Blake disclosed that he works for the Elko County School District but would not personally benefit from this item. Council Member Gorum made the motion to

donate \$500.00 to Trick or Treat Street. The motion was seconded by Council Member Briggs and passed unanimously.

***c. Discussion and Decision to Approve Change Order No. 1 for the N. Gene L. Jones Sidewalk Project (EECBG # EE03271007) and Other Matters Appropriately Related Thereto**

Chris Melville asked that this item be forwarded as the totals came in late and have not been reviewed. Council Member Carter made the motion to forward this item. The motion was seconded by Council Member Blake and passed unanimously.

6. COMMUNICATIONS

Council Member Gorum stated that he had only been able to attend half of the Recreation District meeting.

Mayor Andersen stated that NDOT is preparing to do two phases of road work in the upcoming months.

Council Member Gorum made the motion to approve the claims for October 19, 2010. The motion was seconded by Council Member Carter and passed unanimously.
