

**WEST WENDOVER CITY COUNCIL MINUTES FROM THE
SPECIAL MEETING ON FEBRUARY 27, 2006**

The West Wendover City Council met for a special meeting held on February 27, 2006. The meeting was held at the West Wendover City Offices, Conference Room. Mayor Thaut presided.

The following proceedings were had.

1. CALL TO ORDER AND ROLL CALL

Mayor Thaut called the meeting to order at 6:00 p.m. All those present and excused are noted above.

2. PLEDGE OF ALLEGIANCE

Mayor Thaut led those present in the Pledge of Allegiance.

3. COMMENTS FROM THE GENERAL PUBLIC:

***Possible Decision of the Council Relative to Discussion had in the Hearings Pertaining to the Professional Competency of Those Positions Stated Above**

Chris Melville explained that all Department Heads had received proper notification of the meeting.

Fire Chief – 6:00 p.m. General discussion was had regarding the evaluations given by the Mayor, Council, City Manager and employees. Council Member Miera made the motion to find Jeff Knudtson professionally competent in the position of Fire Chief and award a 3.43% increase to the pay of the Fire Chief. The motion was seconded by Council Member Gorum and passed unanimously.

Chief Financial Officer – 6:30 p.m. General discussion was had regarding the evaluations given by the Mayor, Council, City Manager and employees. Council Member Miera made the motion to find Leon Flinders professionally competent for the position of Chief Financial Officer and to award a 5% increase to the pay of the Chief Financial Officer. The motion was seconded by Council Member J. Carter and passed; Council Member Reilly voted nay. Council Member Reilly stated that the reason she voted nay was not because of the person doing the job but because that is what the job paid.

Mayor Thaut called for a break at 6:45 p.m.

Mayor Thaut called the meeting back to order at 7:00 p.m.

City Manager – 7:00 p.m. General discussion was had regarding the evaluations given by the Mayor, Council, Department Heads and employees. Council Member Miera made the motion to find Chris Melville professionally competent in the position of City Manager and to award a 3.6667% increase to the pay of the City Manager. The motion was seconded by Council Member Reilly.
