

## **WEST WENDOVER CITY COUNCIL MINUTES OF THE SPECIAL MEETING ON MARCH 20, 2006**

The West Wendover City Council met for a special meeting on March 20, 2006. The meeting was held at the West Wendover City Offices, Conference Room. Mayor Thaut presided.

**1. CALL TO ORDER AND ROLL CALL**

Mayor Thaut called the meeting to order at 5:30 p.m. All those present and excused are noted above.

**\*a. Discussion and Decision to Determine Necessary Revisions for the Present Year, 2005-2006 Fiscal Year Budget, Preparation of the Tentative Budget for 2006-2007 Fiscal Year with Department Heads and Other Matters Appropriately Related Thereto**

Leon Flinders explained that the numbers received from the State showed less in property tax and consolidated tax, and more in motor vehicle tax. General discussion was had regarding the revisions for the present year 2005-2006 fiscal year budget as well as the preparation of the 2006-2007 fiscal year budget for the General Government (taxes, business licenses, permits, and intergovernmental revenue), Court Costs and Fines, General Government (wages), Municipal Court, Elections, and Police Department.
